



PRODUCT LIMITED WARRANTY:

DAB Garage Doors (DAB) hereby warrants to the Original Buyer/Property Owner, and other future Homeowners of the property where the door is originally installed, that if the garage door sections sold under this Limited Warranty proves to be defective in material or workmanship that results in cracking, peeling, delamination, flaking, corroding, perforation of the steel metal skin due to rust, and/or discoloration, so long as said door system is used under normal use and service while in accordance with the manufacturer's operating instructions and provided that reasonable annual maintenance to the door system is performed and used under and subject to the terms and conditions of this Limited Warranty as verified upon inspection by persons authorized by DAB, that DAB will repair, restore, or otherwise replace (at DAB's option) any such defective garage door section. DAB warrants it's door sections against deterioration due to rusting-through (defined as metal perforation) as long as the original purchaser and each new homeowner thereafter where the door is located continue to provide the door with reasonable annual maintenance. This Limited Warranty shall be for the benefit of the Original Buyer/Property Owner and all other future Owners of the property on which the garage door was installed and shall become null and void if and when the door is ever relocated to another property, or installed or adjusted by an unqualified installer. This Limited Warranty extends to United States installations only and to normal usage, when the door has been installed by qualified installer in accordance with the manufacturer's instructions.

LIMITED WARRANTY PERIOD:

The Original Buyer/Property Owner will have thirty (30) days from the installation date in which to register this Limited Warranty with DAB at the address indicated below. This Limited Warranty must be registered with DAB within the 30-day period or this Limited Warranty becomes null and void. This Limited Warranty shall commence as of the dated of the installation and shall extend to the original buyer and to each successor homeowner or transferee. In the event the garage door is purchased for use in a non-residential or otherwise in a commercial-type setting then Limited Warranty period shall be limited by time to twenty (20) years of coverage from the original date of installation, under this Limited Warranty.

HARDWARE LIMITED WARRANTY:

DAB will further warrant for a period of five (5) years from the date of installation of this garage door, the springs and rollers to be free of defect in material or workmanship. If the door sold under this Limited Warranty is found to have defective springs or rollers due to defective material or poor workmanship, so long as the door system is operated under normal use and service and in accordance with the manufacturer's operating instructions and provided with reasonable annual maintenance to the door system, as verified upon inspection by persons authorized by DAB, then DAB will replace any such defective spring or rollers. Labor will be at the expense of the Homeowner.

PERMITS BEFORE INSTALLATION:

Before installation, all necessary permits and approvals should be obtained from local and/or state code enforcement authorities to confirm the door has been installed in compliance with local safety and applicability for intended use.

EXCLUSIONS OF THE LIMITED WARRANTY:

This Limited Warranty does not cover the following: 1) rust caused by damages or scratches; 2) damages resulting from exposure to corrosive chemicals, cement dust, condensation, corrosive water runoff, corrosive fumes, or fire; 3) damages caused by accidents, improper use, negligent operation, or improper maintenance; 4) damages caused by improper installation or unacceptable trade practices in certain specified areas; 5) damages caused by any act of Nature that exceed the products' design limits; 6) damages resulting from causes beyond the DAB's control.

NO RESPONSIBILITY FOR DAMAGES:

DAB does not warrant the installation of the door nor defects caused by said installation. This Limited Warranty is void if any of the following occurs: 1) Improper installation techniques; 2) Abuse, misuse, neglect or improper storage; 3) Alteration by reason of applied heat, solvents, chemicals or any other alterations beyond DAB's control; 4) Fire, flood, tornado, named storms, or other storms or casualty, or Acts of Nature; 5) Use in commercial applications, as limited by this expressed Limited Warranty.

DAB MAKES NO OTHER WARRANTIES, REPRESENTATIONS, OR COVENANTS, EXPRESSED OR IMPLIED, WITH RESPECT TO THIS PRODUCT, AS TO ANY MATTER WHATSOEVER, INCLUDING BUT NOT LIMITED TO WARRANTIES, REPRESENTATIONS OR COVENANTS AS TO WORKMANSHIP, DESIGN, CAPACITY, QUALITY, CONDITION, MERCHANTABILITY, OR FITNESS FOR ANY PURPOSE OF THE PRODUCT. UNDER NO CIRCUMSTANCES AND UNDER NO LEGAL THEORY, WHETHER IN TORT, CONTRACT, OR OTHERWISE, SHALL DAB, ITS AFFILIATES, OR ITS SUPPLIERS BE LIABLE OR RESPONSIBLE TO THE PRESENT OR ANY FUTURE HOMEOWNER, IN THE EVENT THIS LIMITED WARRANTY IS TRANSFERRED TO ANOTHER HOMEOWNER, OR ANY OTHER PERSON FOR ANY DIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OF ANY CHARACTER ARISING OUT OF ANY BREACH OF THIS LIMITED WARRANTY, INCLUDING BUT NOT LIMITED TO ANY DAMAGE TO BUILDINGS, OTHER PROPERTY, OR FOR INJURIES OR DAMAGES SUSTAINED BY ANY PERSONS WHOMSOEVER, OR THE RECOVERY OF ANY DIRECT OR INDIRECT COSTS SUCH AS SHIPPING, DELIVERY, PAINT, PAINTING, OR INSTALLATION LABOR CHARGES. IT IS HEREBY UNDERSTOOD THAT THE ORIGINAL BUYER ASSUMES RESPONSIBILITY FOR SELECTING A QUALIFIED GARAGE DOOR INSTALLER TO INSTALL ANY GARAGE DOOR SO COVERED BY THIS LIMITED WARRANTY. This Limited Warranty gives you specific legal rights and you may also have other rights, which vary from state to state.

ACTIVATION OF THE LIMITED WARRANTY:

To preserve Limited Warranty rights hereunder, the Homeowner must, within thirty (30) days of installation, fully complete the attached registration form and mail said form along with a copy of the original invoice to: DAB Doors - Limited Warranty Department, 12195 NW 98th Avenue, Hialeah Gardens, FL 33018. **THIS LIMITED WARRANTY SHALL NOT BE CONSIDERED ACTIVE OR APPLICABLE UNTIL THE REGISTRATION FORM BELOW AND A COPY OF THE ORIGINAL INVOICE IS RECEIVED BY DAB GARAGE DOOR, INC. IN THE EVENT THAT THIS LIMITED WARRANTY IS NOT REGISTERED AS INDICATED, THEN ANY AND ALL ASPECTS OF THIS LIMITED WARRANTY WILL BE LIMITED BY TIME TO THREE (3) YEARS OF COVERAGE FROM THE ORIGINAL DATE OF INSTALLATION.**

CLAIM OF DEFECTIVE PRODUCT:

The Homeowner must notify DAB's Limited Warranty Service Department in writing, at its regular place of business at 12195 NW 98th Avenue, Hialeah Gardens, FL 33018 within thirty (30) days from the date the Homeowner first knows or otherwise becomes aware that the DAB manufactured garage door may not comply with the provisions of this Limited Warranty.

The written correspondence must detail the basis for the claim, the date the garage door was installed, the copy of the original invoice (proof of purchase) showing the company that installed the door, and a copy of the installation permit from the appropriate local and/or state authority (if applicable) showing final approval of the installation Any claim submitted without the installation permit and a copy of the original invoice will invalidate the Limited Warranty claim until such items are provided. Current labor and materials cost may apply in the repair or replacement of any part of the garage door system not specifically covered under this Limited Warranty.

The Homeowner agrees to allow DAB Garage Door Company or its designated representative access to the property in which the garage door is installed. A reasonable time should be allowed by the Homeowner for inspection purposes. If, after inspection, DAB determines that the claim is in accordance with the terms of this Limited Warranty, then DAB agrees at its sole option to repair or replace the section or part of the door system found to be defective.

LIMITED WARRANTY REGISTRATION INFORMATION:

This Limited Warranty is not considered active or applicable until the registration form below is completed and submitted along with the copy of the original invoice to DAB. **In the event that this Limited Warranty is not registered as indicated, then any and all aspects of this Limited Warranty will be limited by time to three (3) years of coverage from the original date of installation.** Please send this form to: DAB Garage Door, Inc.
